### **HC** transfers ex-Shiv Sena (UBT) corporator Ghosalkar murder case to CBI

Mumbai, Sept 6 (UNI):

In a major development, the Bombay High Court on Friday transferred the investigation of former Shiv Sena (UBT) corporator Abhishek Ghosalkar to the Central Bureau of Investigation (CBI). The court today allowed a plea by Teiasvee Ghosalkar, widow of Abhishek Ghosalkar, while directing the Mumbai Police to hand over the investigation papers to CBI at the earliest within two weeks and further directed the zonal director of CBI to appoint an IPS-cadre officer not below the rank of superintendent of police to investigate the case.It also said that the CBI is at liberty to appoint the team of officers. While handing over investigation to the central agency, the court observed that all "angles in the case are not probed" and "such lapses cannot be allowed to continue as it will result in miscarriage of justice".
